I. CALL TO ORDER: 6:30pm

II. STATEMENT OF QUORUM PRESENT:

- **III. PROOF OF NOTICE**: Notice was posted at entrances minimum 48hrs in advance of the meeting. Florida Statute requirement satisfied. Notice was also posted on the community website.
- IV. <u>APPROVE PRIOR MEETING MINUTES (9/27/16):</u> Patrick MOTIONS to approve the 9-27-16 minutes, Joe seconds, unanimous.
- V. <u>PRESIDENT REMARKS:</u> Tree trimming for oak trees in the easement (between sidewalk and roadway) will be begin next week.

Board is reviewing the finding of the informal review of reserves conducted by Reserve Updates. Review uncovered some potential projected shortfalls in town home reserves due to money being withdrawn in 2015 and zero contribution in 2016. Board intends to commission new reserve study next year. - j. Ladders on insurance rider- Jill to check with the insurance agent regarding allowing homeowners to get on ladders to decorate for the holidays. Jill will email the insurance agents response to the board. - JILL
